On behalf of the Board of Directors, I am pleased to report that 2012 has been another successful year in the life of our Society. We sponsored five public events. We began the year with a presentation by Harry Loewen, featuring stories from his new book entitled *Cities of Refuge*. In June, Dora Dueck, Ruth Derksen Siemens, and Sandra Borger focused their presentations on Mennonite women working as domestic servants. Our Annual Fundraising Banquet featured Rudy Wiebe and the 50th anniversary, to the very day, of the publication of his novel *Peace Shall Destroy Many*. In the fall, Royden Loewen was in Abbotsford to help launch his and Steven Nolt's volume in the Global Mennonite History Project dealing with North America entitled *Seeking Places of Peace*. We ended the year with our Genealogy Workshop, featuring Glenn Penner and Tim Janzen.

Our publications committee was very active in 2012, chaired by Maryann Jantzen. The committee produced three very informative newsletters. Article topics included Mennonite spirituality, Mennonite cooperative ventures, and Mennonites and the literary and visual arts.

Last year we re-elected three board members for three-year terms ending in 2015: Wilf Penner, John van Dyck, and Robert Martens. Henry Wieler, who had served as an interim director beginning in 2011, was elected to a two-year term ending in 2014. Henry tendered his resignation from the board for personal reasons this spring, and Vi Chappell from Chilliwack has been nominated to serve out his term. Gerald van Dyck was newly elected to the board to a three-year term. Today we will be asking the membership to re-elect Jim Baerg, Maryann Jantzen, Arnold Klassen, and Richard Thiessen for three-year terms ending in 2016.

We continue to enjoy strong staff and volunteer support that has allowed us to collect, process and preserve historical information in a variety of forms. Our historical and genealogical collections are well-used by the public, and I know that many researchers, from amateur family historians to university scholars, have been well-served by our staff and volunteers.

Thanks to the generosity and loyalty of our constituency, we have again received the necessary financial support to maintain our programs. We are thankful for the support we have felt from our constituency, and will strive to provide the public with a variety of resources that we hope will meet their needs.

Communications

The MHSBC periodical, *Roots and Branches*, appears three times annually, and has attracted some favourable notice. Maryann Jantzen does superlative work as chief editor. Time has sometimes been an issue, as marking season at her university has conflicted with the printing of *Roots and Branches*. There are ongoing discussions on perhaps changing the print times to different times of the year in order to eliminate this conflict. Our webmaster, Elmer Wiens, has made an accessible and attractive place of our website. Book reviews now have their own link on the site.

MHSBC Events

1. March 24, 2012: Harry Loewen presented excerpts from his recent book, *City of Refuge* as well as some of the background notes.

2. June 6, 2012: Dora Dueck, Ruth Derksen Siemens, and Sandra Borger presented an evening on "Mennonite Women Working as Domestic Servants." The latter two focused on the Vancouver *Maedchenheim*. Dora Dueck spoke and read from her novel, *This Hidden Thing*, which deals with the "Girls' Home" of Winnipeg.

3. June 21, 2012: The AGM was held following the volunteer luncheon at ABC Restaurant.

4. October 13, 2012: Rudy Wiebe was guest speaker at the MHSBC annual fundraising banquet. He spoke on the original publication of his first novel, *Peace Shall Destroy Many*.

5. November 1, 2012: A book launch was held for Royden Loewen's and Steve Nolt's *Seeking Places of Peace*. This is the fifth and final volume in the Global Mennonite History Project series.

6. November 17, 2012: Tim Janzen and Glenn Penner presided over the annual Genealogy Workshop.

In coming months, Robert Martens will have more time to pursue this project. Hardcopy versions of the yearbooks are also kept in the archives room.

2. InMagic

Dolores Harder, Helen Nickel, and Laura Unger have made major progress on filing and cataloguing archival documents. We will be having discussions on uploading our InMagic files to a central archival website. Sylvia Stopforth continues to be a great help with the InMagic program.

3. Microfilm digitization

Board member Don Fehr reports: "The major project that is being worked on is EWZ digitization. We are nearing the 40% completion point, with 949,000 of approximately 2.5 million frames done. A big thank you goes out to Jim Baerg and Wilf Penner for all their efforts and perseverance. They are working very hard at this challenging job. It is our intention to send out an interim release to our partners later this year."

4. Indexing

MB Herald birth and marriage announcements are being added to our database as an ongoing project. *Mennonitische Rundschau* obituaries are indexed. *Der Bote* indexes have been uploaded and the digitization of the actual issues continues. EWZ files are being prepared for the GRANDMA database. *Canadian Mennonite* marriage notices are being indexed, this also an ongoing project.

Ongoing archival work

Erna Block has made remarkable progress on the organization of photos. Laura Unger has been working on our map collection. And as always, the genealogist volunteers continue to do their "detective work" with unstoppable energy. Visitors are sometimes astonished at how seriously queries on their ancestral heritage are taken.

Library

Arlene Peters has finished cataloguing the lending and reference library.

The MHSBC office has received several valuable donations over the past year, including two antique clocks. One a Mantler Clock circa. donated by Martha Wiebe and a Kroeger clock donated by Sara & the late Peter Heinrichs.

Thanks also to Mary Ann Quiring, Elisabeth Klassen and the office volunteers who work to get each issue into the mail in a timely fashion.

Mennonite Historical Society – Capital Endowment Fund

Investment Committee Summary

The MHSBC – Endowment Fund, currently known as the Edward D. Hildebrand Endowment Fund, was established in February, 1998 to provide ongoing income to the MHSBC. The initial donation was provided by Mr. Hildebrand.

The MHSBC – Endowment Fund was established to provide an annual income to the Society for general operations. Currently the Fund provides \$12,000 per year of income to the Society.

The fund balance as at December 31, 2011 totaled \$309,473 income for the year including capital gains totaling \$27,350 and after transferring \$12,000 to operations the Fund balance as at December 31, 2012 was \$324,823.

As of March 18th, 2013 the Fund has earned 8.8% during the past year. The Fund has performed very well achieving 9.46% annualized earnings over the past ten years.

The Fund is managed by an investment committee made up of six members and meets quarterly during the calendar year. The committee members are Edward Hildebrand, Peter Neudorf, John Konrad, and Richard Thiessen with two new members, Arnold Klassen and Bob Weinreich in 2013. Mr. Klassen is serving as Chairman.

The committee meetings are informal assemblies of the members and Bill Acorn, Investment Advisor, CIBC Wood Gundy, who provides portfolio statistics and market information for consideration.

This committee and our society are indeed fortunate for the contribution of time, experience, and wisdom of our long term members; Messrs. Hildebrand, Neudorf and Konrad and we look forward to that continued benefit.

Accountant Review

To the Directors Mennonite Historical Society of BC Abbotsford, B.C.

I have reviewed the Balance Sheet of the Mennonite Historical Society of British Columbia as at December 31, 2012 and the Statement of Income and Expense for the year then ended. In so doing, I accepted the statements received from the Society's bank and the holder of its investments and did not conduct independent enquiries. The Society's accounting being conduced on a cash basis, I did not test for any liabilities outstanding as at year end.

In common with many charitable organizations, the Society derives part of its revenue from the general public in the form of donations and membership fees which are not susceptible to complete verification. Accordingly, my verification of revenue from these sources was limited to a comparison on a test basis of recorded receipts and bank deposits by the Society and I was unable to determine whether any adjustments might be necessary to donation revenues and membership fees and their impact on total revenues reported on the Statement of Income and Expense.

The Balance Sheet and the Statement of Income and Expense reflect fairly the financial position and the results from operations of the Society for the Year 2012.

Financial Report

During 2012, the supporters of the Mennonite Historical Society of B.C. ("MHS") have once again been most generous in their gifts of time and financial support that have allowed the MHS to end the financial year in a very strong financial position. The October 2012 Fund Raising Banquet was again our largest source of donations which raised \$26,810 for the MHS after expenses.

Total donations for the year were \$60,283 compared to a budget of \$63,726. Total receipts increased from \$95,437 last year to \$100,706 (after removing the impact of investment losses for the year). The \$14,662 loss on investments is due to the realization of losses on certain investments sold during the year. Offsetting this was an increase in the market value of investments held by \$30,012. Total cash on hand decreased from \$75,052 as at December 31, 2011 to \$72,514 as at December 31, 2012.

Total expenditures for the year were \$102,568 compared to a budget of \$92,926 an increase of \$9,642. A large part of this increase is due to the higher costs of Books and DVD's sold. Offsetting this increase was a large increase in book and DVD sales which increased from \$7,381 to \$15,546 and increase of \$8,165. The operating deficit totalled \$16,524 for the year and with the increase in the investment portfolio the MHS ended the year with an increase in Members Equity of \$13,488.

Again, with generous support of our members with both in time and in funds the MHS has been able to carry out its mandate for another year and for that the Board of Directors are most grateful.
